The 1-3 Year U.S. Treasury Index Fund is an exchange-traded fund (ETF) that aims to capture the returns of the Merrill Lynch 1-3 Year U.S. Treasury IndexSM.¹ By tracking the index, the Fund aims to achieve the yield, capital preservation and low volatility level inherent in this index.

The Fund shares are publicly traded, offering accessibility to any investor who can access a major stock exchange. The ETF structure allows for pricing and trading throughout the day with the same expense ratio for all investors, regardless of investment size.
